SWIMMING POOL RULES

REGULAR HOURS: 7:00 a.m. to 8:00 p.m. – SEVEN DAYS PER WEEK SUMMER: MON-FRI 12:00 p.m. to 7:00 p.m. / SAT-SUN 10:00 a.m. to 7:00 p.m.

USE OF THE POOL IS AT YOUR OWN RISK AS THERE IS NO LIGEGUARD ON DUTY AT ANY TIME.

Anyone abusing the pool rules may be asked to leave immediately and/or be subject to subsequent Board action.

- 1. The pool and pool area are exclusively limited to Marbella Park Homeowners' Association residents and their invited guests.
- 2. A maximum of six (6) guests per dwelling unit are permitted in the pool area at any given time. An adult* resident must always be in attendance with his/her guest(s).
- 3. The buddy system is recommended for use by all swimmers.
- 4. Anyone under fourteen (14) years of age must be accompanied by an adult* resident.
- 5. All gates and restroom doors must remain locked at all times when not used for entry or exit purposes by residents or their invited guest(s).
- 6. NO GLASS CONTAINERS OR ALCOHOLIC BEVERAGES OF ANY KIND ARE ALLOWED IN THE POOL AREA.
- 7. No surfboards, metal objects, bicycles, or other large objects permitted in pool area.
- 8. Only small STYROFOAM and inflatable items designed for "pool use" are allowed in the pool. Adult* supervision and discretion in the use of such items should be exercised.
- 9. Swim fins capable of marking pool walls are prohibited.
- 10. No pets are allowed in the pool area at any time.
- 11. No diving, running, pushing or horseplay is allowed in the pool area at any time.
- 12. No nudity allowed at any time.
- 13. No lifesaving equipment or pool furniture may be played with, destroyed, or placed inside the pool.
- 14. Only garments specifically designed as bathing suites shall be worn in the pool. No cutoffs are allowed.
- 15. Infants, young children and anyone not normally subject to the control of natural body functions must be fitted with bathing apparel having snug-fitting leg openings. Cloth diapers are prohibited in the pool. Diapers must be plastic-covered and fit snugly.
- 16. Excessive noise, including loud radios, or water play that is disruptive is prohibited.
- 17. Bubble bath and other substances are prohibited in the pool.
- 18. Barbeques are not allowed in the pool area.
- 19. If card is lost or stolen, first replacement card is \$20.00. Any additional replacement fee is \$50.00.
- 20. Unit owner will be held responsible for any damages caused by homeowners, family members, and guests. The homeowner's liability is primary. Please monitor the activities of your children and guests.

A private security agency, or other designated agency, may be appointed by the Board, at its discretion, to enforce these rules. Reported violators may become subject to subsequent Board action.

Common courtesy and consideration for the rights of others are essential for the full enjoyment of these facilities by everyone.
